Mayor and Council did review bids for accounting services there were three different bids that were submitted to the City.

Williams-Keepers LLC bid proposal is \$160.00 an hour capped at \$2,000 for each semi-annual compilation.

Winfrey Certified Public Accountants LLC proposal is \$6,000 for each semi-annual compilation.

Painter Business Services LLC bid proposal is \$1,000 for each semi-annual compilation.

Alderman Ashley Long made a motion to hire Williams-Keepers to do the semi-annual compilation. The motion was seconded by Alderman Stan Robinson with three in favor.

Mike Jacoby with Planning and Zoning Commission spoke to Mayor and Council about Portable sheds and car ports on someone's personal property there are no setbacks. At this time Sturgeon does not have an Ordinance that requires setbacks for sheds or car ports at this time.
